

Privacy Policy for FlavorFlix

Introduction

011 Software LLC ("we," "our," or "us") operates the FlavorFlix mobile application (the "Service"). This Privacy Policy explains how we collect, use, disclose, and safeguard your information when you use our Service.

By using FlavorFlix, you agree to the collection and use of information in accordance with this policy.

Information We Collect

Information You Provide Directly

When you create an account, we collect:

- Name
- Email address
- Password (encrypted)

Information Collected Automatically

When you use FlavorFlix, we collect:

- Recipe generation requests (media titles you enter)
- Saved recipes and preferences
- App usage analytics (for users with in-app purchases only)
- Dietary preferences and cuisine selections

Information We Do NOT Collect

We do not collect:

- IP addresses or location data
- Device identifiers beyond what's necessary for account functionality
- Photos or camera access
- Contact lists
- Browsing history outside our app

How We Use Your Information

We use your information to:

- Provide and maintain your account
- Generate personalized recipes through our AI service
- Save and retrieve your favorite recipes
- Process in-app purchases
- Improve our Service functionality
- Provide customer support
- Comply with legal obligations

Data Storage and Security

Your data is stored on secure servers hosted by Render. We implement appropriate technical and organizational measures to protect your personal information against unauthorized access, alteration, disclosure, or destruction.

- Passwords are encrypted using industry-standard methods
- Secure HTTPS connections for all data transfers
- Regular security updates and monitoring

Third-Party Services

We use the following third-party services:

OpenAI

We use OpenAI's API to generate recipes based on your media inputs. Only the media titles and your preference settings are shared with OpenAI. OpenAI processes this data according to their privacy policy.

Payment Processors

- **Apple App Store:** For iOS in-app purchases
- **Google Play Store:** For Android in-app purchases

These payment processors handle all payment information directly. We do not store credit card numbers or payment details.

Render

Our hosting provider, which stores your account data and saved recipes securely.

Your Rights and Choices

Access and Portability

You can access all your saved recipes and account information through the app settings.

Account Deletion

You can delete your account at any time using the "Delete Account" button in the app settings. This action will:

- Permanently delete your account information
- Remove all saved recipes
- Cancel any active subscriptions (though you retain access until the end of the billing period)

Data Correction

You can update your account information at any time through the app settings.

International Users

If you're located in the European Economic Area (EEA), you have additional rights:

- Right to access your personal data

- Recipes are AI-generated and should be reviewed for safety and accuracy
- We are not responsible for allergic reactions or food safety issues. In every recipe page we warn you of potential allergies
- Always follow safe food handling practices
- Consult dietary professionals for specific health needs
